City of Highfill AR Business License Information

Section 8. License Fee Schedule .

(a) Any person who shall engage in, carry on or follow any trade, business, profession, vocation or calling, within the corporate limits of the Town shall pay an annual license fee of \$20.00 per year plus \$2.50 for each of the first 25 employees employed by such business, excluding the owner of a sole proprietorship, and an additional \$1.00 per year for each and every employee over 25. The maximum fee to be paid by any licensee under this Ordinance shall be \$150.50 per year. The number of employees upon which the license fee shall be based shall be the average number employed by the applicant during the preceding calendar year. It shall be the duty of the Town Recorder to determine the number of employees upon which to base the fee and the Town Recorder shall require of all applicants an affidavit stating the number of employees upon which such a fee shall be paid. In addition, the Town Recorder may require other proof in order to correctly determine the number of employees upon which the license fee shall be based.

This license is only required if you will be selling items at the event. It does not interfere with your state business license. It is basically a vending permit for the City of Highfill.

Please bring the form on the next page with you to the event; the city will be there collecting forms and fees. Do not worry about notarization. The fee will be no more than \$20, but possibly less.
